

## 2008 /2/14 Green Energy (3519TT) announces share buyback plan

Please be informed Green Energy (3519TT) has announced a share buyback plan approved by the Board of Directors as following

1. To repurchase up to NT\$1.6 billion or no more than 3 million of the Company's common shares from the open market.
2. To buy back shares at a price in the range of NT\$100 to NT\$180 per share from February 15, 2008 to April 14, 2008.
3. The shares to repurchase account for approximately 3.11% of GET total outstanding shares.
4. The repurchased shares will be utilized for employee encouragement planning.

Please also be informed Green Energy monthly revenue in January, 2008 reached new high number NT\$ 642million. Green Energy's operation and planning on solar silicon crystalline and thin film businesses are on going as scheduled.
